Community Grants 2024/25

Do you represent a community group or organization?

The 2024/25 Community Grant application process is open from MONDAY NOV 11th and the Council welcomes requests from groups which help and involve local people. The Parish Council can only award grants using certain legal powers; specific powers allow the Council to provide funding for specific activities or projects which Members feel will be of benefit to residents of Shenstone, Stonnall or Little Aston.

Past beneficiaries include Playing Fields and Village Halls in all Wards, Scouts/Guides/Brownies, Fotherley Hall, Stonnall Gardeners Guild, Shenstone Tennis Club & Little Aston Bowls Club.

It is a condition of any grant application that the group or project must bring direct benefit to the residents of the Parish. All applications must clearly demonstrate how this will be achieved. The group should be a charity, voluntary or community organisation. Applications will not be considered from individuals, businesses, religious or political groups unless permitted by legislation.

Grant applications will be considered at the Finance, Legal Health & Safety Committee meeting in January with recommendations put before the next meeting of Full Council. Therefore applications and any supporting documentation should be received by January 2nd 2025 to allow the Clerk to check that the Council's grants criteria have been met.

Overhanging Trees



If your neighbour's tree(s) is overhanging your property, we first advise you to talk to your neighbour - they may be unaware that it is causing you a problem.

Take some time to think about what problems you are having, write them down if it helps, so that you can approach your neighbour calmly. Sometimes taking a few photos to show them can help them appreciate your concerns.

If they decide not to act, then you can arrange to prune back any overhanging branches - but only as far as the boundary. Remember to return the branches to your neighbour or ask them how they would like the branches disposed of.

Before you do any work we advise you to check whether the tree is protected. If it is protected you will need to apply for consent to do the work.

Field to be Proud of



Stonnall and Lynn Playing Field Association applied to Shenstone Parish Council and were granted funded money towards some new goal posts, and repairs to the pitch. The works were completed at the beginning of September, and the pitch and the new posts look fantastic. The football foundation also contributed towards the new goal posts. Our local district council carried out the work to a high standard.

It's a pitch to be proud of, and the Parish Council also fund the grass cutting on a regular basis.

Stonnall Neighbourhood Plan Refresh

Following a packed room of more than 116 people at Stonnall Village Hall on September 11th, the next meeting of the Stonnall Neighbourhood Plan Group is set for Friday 1st November 2024 at 7.30pm. At that meeting, set to take place at Stonnall Community Centre, it is planned to involve the public in as wide a way as possible in moving forward to draft out the revisions required to update the current plan which is dated 19th April 2016.

The Stonnall Group has secured Government funding of £10,000 to be specifically spent on this refresh of the existing Neighbourhood Plan and must be completed by 31st March 2025.

To help in the plan's revision, The Stonnall Group is using the same firm of specialist consultants that Little Aston and Shenstone are engaging in their plan revisions.

Given the planned Government increases to housing allocations and mention of possible changes to the green belt it is felt more important than ever for Communities to have a strong Neighbourhood Plan in place which may help them in discussions with Local Authorities when making decisions on development plans.

Bleed kits installed in Stonnall

Following a great initiative by a Stonnall resident, two bleed kits have been installed in Stonnall- at the Village Hall & at the Community Centre.

Little Aston Village Hall – Proposed Additional Room keeping busy!

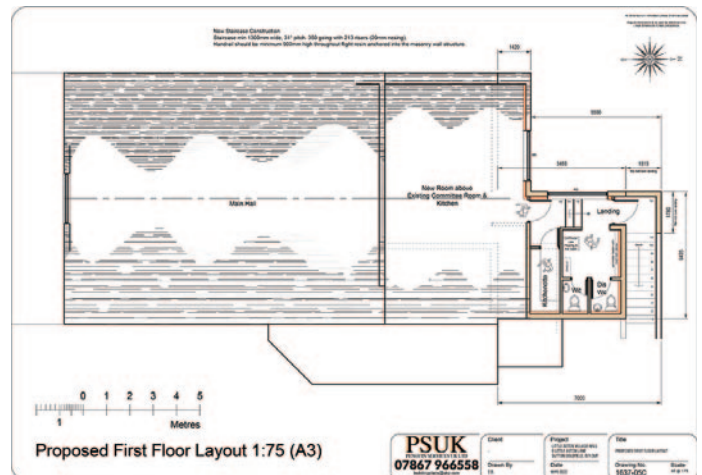
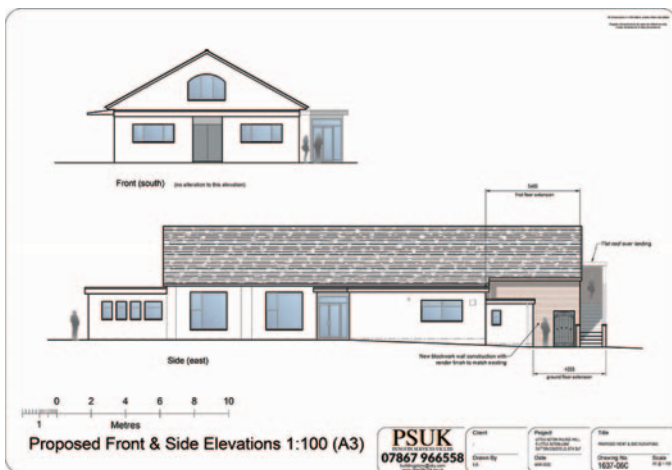
The fund-raising process for the much-needed additional room at the Village Hall is still in progress. To date, the Hall has secured £189,000 towards the £225,000 that will be needed before construction can commence. The £189,000 consists of £75,000 that the Hall has accumulated towards the project and generous grants from Shenstone Parish Council, the Owen Family Trust, the Platinum Jubilee Village Hall Fund, the National Lottery, and the Enover Community Fund. Applications have also been made to four further grant sources. If sufficient of these further grant applications are successful, then it is hoped that construction will begin in January 2025.

As many of the readers will know, the Village Hall site and the Hall itself are leased from the Lichfield Diocesan Trust under the terms of a 99 year lease dated 26th February 2003. The Trust holds the land and the Hall for the benefit of the residents of Little Aston and the surrounding area. Whilst the trustees of the Trust fully support the project, quite properly, they require sufficient funds to have been secured for the project to be completed in full inclusive of a 10% contingency before they will give permission

for the project to go ahead.

Whilst the additional room is being created within the loft area that is above the existing Committee Room and Kitchen, the Committee Room will be given a substantial upgrade. Its external walls will be insulated, the walls will be plastered, noise insulation will be installed between the room and the Main Hall, double glazing will be installed together with a new double-glazed door to the Bowling Green, and the heating system will be replaced with child safe perimeter heating. Also, the Committee Room toilets will be extended upwards to create toilets and a kitchenette for the additional room and outwards to create an access and entry lobby for the additional room. The additional room will therefore be able to function without affecting the users within the Hall and the Committee Room.

Once the additional room is completed, the Hall will be able to accommodate many more of the groups who have applied to use the Hall but who cannot be accommodated because the requested room is already in use by others.

Do You Fancy Exploring the Thermal Efficiency of Your Home?

Shenstone Environment Group have a thermal camera to loan out to anyone from across the Parish interested in exploring whether or not their homes have a heating issue. A condition of the loan is that borrowers must hold a current Staffordshire County Council Library Card.

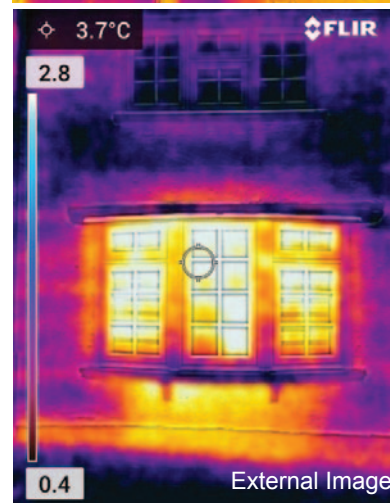
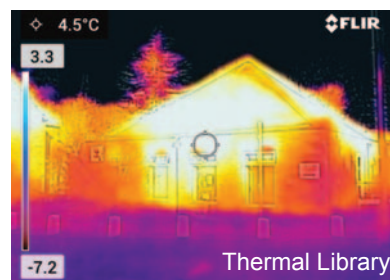
The camera uses infra-red radiation to take images of buildings which, instead of giving a lifelike photograph, effectively provide a "temperature map". These images can then be used to help identify points of heat loss, which may be either internal or external.

The images could reveal problems with, for example, insulation, draughts, damp, or clogged radiators and underfloor heating. Once any such locations have been identified remedial action can then be taken which results in improvements in comfort, financial savings, and a reduction in the building's carbon footprint. Often there are simple solutions which the home owner can implement, but more complex ones may require professional help.

The heat loss images of the exterior of a building are best obtained when there is around a 10°C temperature difference between the inside and outside. Consequently, we are running the loan scheme from November to mid-April.

The camera is housed in Shenstone Community Library and loaned out from there, generally for 7 days, from Saturday to Friday. However, the camera will only be available once a borrower has received instruction in its operation, and this will be provided through evening training sessions held in the library.

SHENSTONE OLD CHURCH TOWER

It's been a busy summer for Shenstone Old Church Tower and now more than 2,000 visitors have taken a step back into village history since its opening.

And there is no let up on demand for people to see into Shenstone's past and take in a panoramic view of the nearby countryside.

Historian Bronwen Ross continues to attract visitors giving 'an insight into some of the notable and notorious characters of the village with her graveyard tours, combining it with tours of St John's Church which opens at the same time.

Once again, the Tower will become a Christmas beacon with lights being switched on in December.

Information boards are now on every stage of the Tower stairway and the design of a toposcope is well advanced to highlight the points on the landscape from the viewing platform.

The Tower is also now on TripAdvisor and efforts are being made to involve it within education curriculums at local schools.

Opening dates for the next 3 months are are: 2nd November, 7th December and 4th January; 10:00 – 12:00.

Shenstone Fun Run Brings Village Together and Raises £12,500 for Greysbrooke School

Shenstone Playing Fields were alive with excitement on Sunday, 29th September, as the Greysbrooke School PTA, 'FROGS', hosted the much-anticipated 2024 Shenstone 10k Fun Run. Making a triumphant return after a five-year break, the event attracted over 400 enthusiastic participants (including a giant acorn!) and hundreds of cheering spectators. Thanks to their collective efforts, an impressive £12,500 was raised for the school, along with a generous donation to Acorns Children's Charity and Shenstone Scouts.



This success would not have been possible without the support of the local businesses. 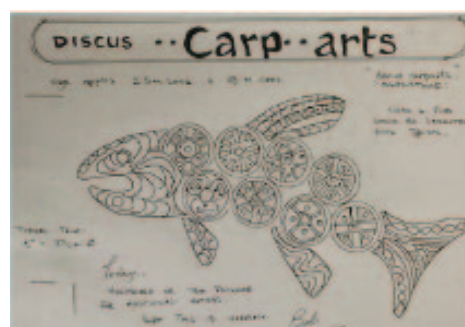

Update on Shenstone Playing Fields Management Committee & Country Club Lease

It has been several months since the Management Committee of the Playing Fields resigned en-bloc. At that point to ensure that the day-to-day management of the facilities was able to continue, the Parish Council, as Custodian Trustees, took responsibility for what was hoped would be the short term. It has turned into much longer than anticipated for the reasons outlined below:

1) The replacement of the Management Committee.

In order to proceed with an EGM and the formation of a new committee we require confirmation from the Charities Commission as to which of the previous Constitutions they consider is the correct one. Despite several long telephone conversations, letters and the intervention of our M.P. to speed up the process we have not been given any indication as to when the required decision will be made so cannot act.

Applications for the vacant positions have been received and, once the constitution is confirmed, those community bodies with representation will be contacted. As soon as we have more clarity, we will share it accordingly.

2) The Country Club lease.

Residents may or may not be aware that the lease under which the tenant has control of the building is due for renewal at the beginning of the New Year. Under normal circumstances, negotiations would have been well advanced, and it was certainly the hope of the Parish Council that a new Committee would address this as a priority. With less than three months of the current lease left the Tenant may now serve notice for the continuation of the lease on the existing terms. This is not something that the Parish Council can allow to happen as the lease is not fit for purpose & a much improved outcome must be secured for the future of the Playing Fields. Therefore, the Parish have had to appoint a working party of Councillors to work on this as well as appointing Legal representation and a surveyor to ensure everything is dealt with thoroughly. Negotiations have already started for a newly constructed lease with improved rent and better clarity in respect of the boundary of the property, access, security, the tenant's responsibilities and what will be the new Management Committee's responsibilities. The tenant is very keen to work with us on a new lease, building on the strong, positive mediation position proposed earlier in the year.

In the meantime, with the continued invaluable assistance of individuals who look after the schedules and the maintenance of the Playing Field, football bookings carry on as normal. Access to the changing room facilities have recently been improved following a very regrettable theft of personal belongings during a match and fire alarms in the changing rooms, as well as improved safeguarding measures, implemented.

Extensive tree landscaping has taken place around the play area and the damaged side bar around the pitch is scheduled for repair very soon following a problem with sourcing the required materials.

Finally, the annual playground inspections are scheduled soon, as they are also for Stonnall & Little Aston.

Lichfield District Council Issues and Options Consultation

Lichfield District Council (LDC) is actively working on a new local plan and once adopted it will be known as the Local Plan 2043.

The Local Plan: Issues and Options document is the first formal consultation stage in the preparation of the new local plan for the district and regulations state that the council is required to consult with stakeholders about what it considers the scope of its plan to be and the key issues that will need to be addressed.

An Issues and Options document with supporting papers has been produced and is available on the LDC website as the Council is seeking comments from interested parties that will inform the future stages of the local plan's progression.

The consultation period will run from 30th October to 11th December 2024 and there will be a wide range of methods in which people can respond to the Issues and Options document, the Habitat Regulations Assessment and Sustainability Appraisal.

Hard copies of the consultation document will be available from the District Council House and Burntwood Leisure Centre.

There will also be drop in events at venues including The Guildhall Christmas Market, Burntwood Leisure Centre, Lichfield Golf and Country Club and various Schools and Colleges in the area.

A social media campaign will also be in place and LDC plans to work locally with Parish Councils to get as much community involvement as possible.

Stonnall Public Meeting 11th September 2024

A capacity meeting of 116 residents coupled with more than 20 attendees who watched live via a Teams 'Town Hall' broadcast, came to hear about new Government housing plans coupled with possible Green Belt changes. County Councillor David Smith and Lichfield District Councillor Phil Whitehouse called the meeting to explain to local residents the possible implications of Government development proposals on Stonnall and their impact across the whole District.

This is because the Government proposes that Lichfield District Council (LDC) should increase its housing numbers over the next 5 years by 2,500 over and above the numbers identified in the Authorities "Needs Analysis" which had already identified the areas requirements.

The meeting considered the impact on highways and the possible major problem of driver's 'rat- running' through Villages like Stonnall and its surrounding lanes.

Residents were also informed about LDCs' recent 'Call for Sites' programme whereby developers and landowners can suggest sites for residential and commercial development. In the Stonnall area there have recently been 7 sites put forward totalling a possible 1029 dwellings, but most of these sites had been put forward in previous "Call for Sites' activity.

It was fully explained at the meeting that a 'Call for Sites' exercise is a recognised way for Councils to find out what land maybe available for future development and that residents should not be unduly concerned as it is no way certain that any of these identified sites would ever be developed. Attendees were assured that all will be done to protect the greenbelt.

Residents also heard that the imminent revisions to the emerging Stonnall Neighbourhood Plan would also have to consider these issues and a call was made for residents to contribute their views at the various Neighbourhood Plan meetings.

The next meeting of the Stonnall Neighbourhood Plan Group is on Friday 1st November at 7.30pm in the Stonnall Community Centre.

Speakers at the meeting included LDC Cabinet Members Janice Silvester-Hall and Alex Farrell, who also are Councillors for Staffordshire County Council.
